**Nature of Duties:** The 'Physiotherapist Consultant' will provide specialised physiotherapy care/services to the CBI officers/ officials.

**Terms and Conditions towards engagement of 'Physiotherapist Consultant' :**

1. The said engagement as 'Physiotherapist Consultant' is purely temporary in nature, initially for a period of 1 year for rendering of satisfactory physiotherapy care/ services. However, the engaged 'Physiotherapist Consultant' shall have no right to terminate the contract midway.
2. The engaged 'Physiotherapist Consultant' shall have no right to claim regularisation/ absorption in CBI/ any other Government organisation/ department etc.
3. The engagement of 'Physiotherapist Consultant' can be terminated at any time by CBI without assigning any reasons thereof. The Physiotherapist Consultant shall not ask CBI about the reasons of termination.
4. The 'Physiotherapist Consultant' shall be required to visit CBI, Head Office, Plot No. 5 B, CGO Complex, Lodi Road, New Delhi for 03 hours daily on 05 working days in a week.
5. The engaged 'Physiotherapist Consultant' shall be required to sign an agreement of confidentiality and absolute integrity.
6. The engaged 'Physiotherapist Consultant' shall be paid a suitable fixed amount per month for each completed month of engagement. He shall not be paid any other remuneration/ allowance etc.
7. The Income Tax or any other tax liable to be deducted, as per the prevailing rules shall be deducted at source before effecting the payment for which the CBI will issue TDS certificate.

8. The engaged 'Physiotherapist Consultant' shall have to bear himself/ herself, the expenditure for commuting to CBI, Head Office.

9. The engaged 'Physiotherapist Consultant' shall carry his/her own physiotherapy equipments for providing the proposed service. CBI shall provide necessary space for the purpose.

10. A committee of CBI officers shall conduct a pre-engagement personal talk with the shortlisted eligible and willing professionals for their selection. The decision of the said committee shall be final. The applicants who do not qualify for engagement shall have no right to seek the reasons thereof.

11. CBI shall verify character, antecedents and educational qualification etc of the selected candidate before their engagement.

12. The engaged 'Physiotherapist Consultant' shall be issued a 'Photo Temporary Identity Card/ Duty Pass' for facilitating his entry into the CBI, HO Building. Any misuse/abuse of such facility shall lead to automatic termination of the contract in addition to necessary legal action.
