- Doctors will not be entitled for any other Allowance or Benefits other than the indicated above and will not confer any right to claim the Benefits/Facilities on par with regular employees of the Company.
- Doctors will abide by the Company's Rules and Regulations governing their engagement.
- Doctors will safeguard the security and confidentiality of all official matters a secrecy of information coming to their knowledge.
- Doctors will be covered under the Income Tax, Service Tax, Professional Tax etc. as per the applicable rules. All such Taxes would be deducted from the remuneration payable to them.
- Doctors are required to visit the Company Hospital on suitable days as per the requirements of the Organization for providing treatment to employees and their dependent family members. In the event of

emergency, they will be called as and when required. The Schedule of visits required will be finalized by Head of Medical Department, TAD, Kanpur.

- The Part time engagement is liable to be terminated by giving one month's notice in writing from either side. Further, the part time engagement will stand automatically terminated on completion of the prescribed tenure.
- Initial engagement will be for a period of 02 (Two) years. Further, extension for engagement, as per Company's policy, may be considered based on performance of GDMOs/ Homoeopathy Doctor and also requirement of the Division.
